#### 1. General Product Description

Foliodrape<sup>®</sup> PROTECT PLUS drapes made of soft, two-layer material and pad material; impermeable to moisture and bacteria; abrasion-resistant and low linting; well comfortable; self-adhesive drapes with safe adhesive for rapid positioning around the operation site. Extremity drapes and Hand/foot drapes with elastic cuff.

Foliodrape<sup>®</sup> PROTECT PLUS drapes carry the CE-mark according to EU directive 93/42/EWG for medical devices. The product is classified as a class I medical device. A conformity assessment has been performed for Foliodrape<sup>®</sup> PROTECT PLUS drapes and it has been shown to be in compliance with all applicable requirements of the above mentioned directive. The safe use of Foliodrape<sup>®</sup> PROTECT PLUS, therefore, is ensured if the product is used in line with the intended purpose.
