



UTAH PEACE OFFICER STANDARDS AND TRAINING RELINQUISHMENT OF PEACE OFFICER CERTIFICATION

I, ARROW RHOADES, voluntarily relinquish my peace officer certification issued by the State of Utah, Department of Public Safety, Division of Peace Officers Standards and Training (POST). By signing this relinquishment form, I understand and acknowledge that:

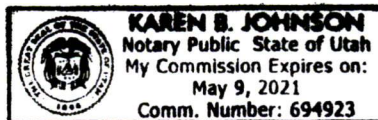
1. A disciplinary issue regarding my conduct has been referred to POST.
2. POST will conduct no further investigation regarding this referral and there will be no further adjudicative proceedings regarding my peace officer certification.
3. I am waiving any right I may have had to a hearing before an administrative law judge as provided by Utah Code Ann. § 53-6-211.
4. The relinquishment of my peace officer certification is non-revocable and I may not subsequently be certified as a peace officer in the State of Utah as provided by Utah Code Ann. § 53-6-211.5.
5. I will no longer be a certified peace officer and will not be able to exercise any peace officer authority when this form is submitted to POST.
6. Record of this relinquishment may be entered on the National Decertification Database administered by the International Association of Directors of Law Enforcement Standards and Training or other law enforcement related databases maintained for the purpose of recording peace officer decertification and relinquishments.
7. Investigative notes, reports or documents created or maintained by POST may be subject to release under the provisions of the Government Records Access and Management Act (GRAMA) found in Title 63G, Chapter 2 of the Utah Code.
8. By recognizing the voluntary relinquishment of my peace officer certification, POST is not subjecting me to decertification for disciplinary reasons and POST will not report my voluntary relinquishment as a judgment of decertification.
