Decision taken: *Coordinators mandated the Chair to inform the CCC that authorisation for Public Hearings will be requested, if necessary, on an ad-hoc individual basis and that no activities with National Parliaments are foreseen for the first half of 2023.*

3.2 Nomination of ENVI expert for IMCO hearing on construction products

Decision taken: *Coordinators nominated a representative of ECOCEM as the ENVI expert for the IMCO hearing.*

3.3 ENVI input for CCC exchange on Parliamentary committees' scrutiny of the implementation of the UK Withdrawal agreement (WA) and the EU-UK Trade and Cooperation Agreement (TCA)

Decision taken: *Coordinators mandated the Chair to send a letter to the CCC Chair requesting that ENVI be associated with exclusive competences with respect to the implementation report on the TCA and that the implementation should cover all aspects of the TCA.*

3.4 Handling of IMO MEPC 79 in December 2022

Decision taken: *Coordinators endorsed the proposal to invite the Commission to an exchange of views in the ENVI committee prior to the start of MEPC 79 and to organise technical briefings with the Commission with interested Members.*

Decision taken: *Coordinators took note of the information about the remit of the report given by AGRI and decided to request association under Rule 57 on issues under ENVI remits.*

Decision taken: *Coordinators took note of the information that FEMM members will be invited to the Joint ENVI-LIBE hearing on the topic of “depathologisation of transgender and non-binary persons” and of the request to groups to submit names for possible speakers by Monday 19 September COB.*
