
IN RE: CERTIFIED PROCESS SERVERS

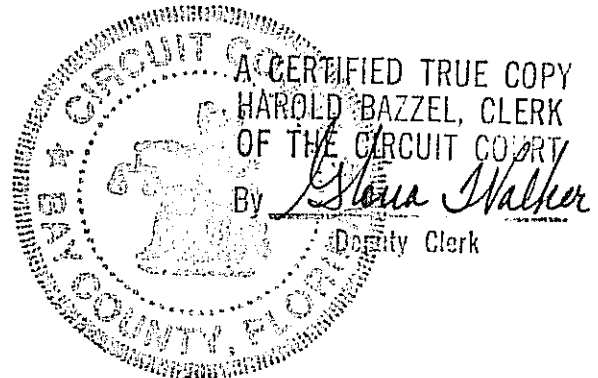
A copy of this order shall be maintained by the Court Administrator and each Clerk of the Circuit Court in this circuit.
