





Town of Liberty, NY January 3, 2024 Town Board Meeting Update on Projects

1. CDBG Grant Project Phase 10 – White Sulphur Springs Boyd Road and Well Screens

- Actions for the Board to consider at today's meeting:
 - No resolutions required
 - Review construction status and remaining work for the original project (Tweedie)
 - Review plan forward and schedule to complete additional paving on Boyd Road
 - Review the Town's project completion date extension to NYSOCR
 - Review the plan forward and schedule
 - Review cost summary and projections/planned expenditures
- Actions for Board to consider at the next January 2024 meeting
 - Review and consider approval & execution of DEDPC's Engineering Service Agreement Amendment for additional Engineering services associated with unplanned/additional restoration work for Boyd Road
- Project was identified for award of a grant of \$787,700; the Town agreed to fund grant administration (Blauer Associates) at \$45,000 to facilitate project readiness and score more points on the application
- Work includes replacement of approximately 1,650 lineal feet of 6" waterline from the connection on Warden Lane to the end of
 the line on Boyd Road. Horizontal directional drilling (HDD) will be used to install 6" HDPE lines under Route 52 (required by
 NYSDOT) and under the stream/wetlands on Boyd Road. The remaining piping will be ductile iron. New valves and hydrants
 and services to the shutoff box will be provided. Also includes work to replacing Shore Road Well 1 screen.
- Mark Bauer continues to work through NYSOCR items
- NYSDOH design review is complete. Final approval was received on 6/14/23.
- NYSDEC permit for boring under wetland area received on 7/7/23
- Construction Status and Remaining Work for the Original Project (Tweedie Construction)
 - Contract was awarded at the April 17, 2023 meeting and execution copies of the construction contract have been prepared and distributed to the contractor and the Town
 - NYSDOT Work Permit has been obtained by the contractor
 - A pre-construction meeting was held on June 14, 2023
 - Work started in mid-September and all contract work (for the original project, Tweedie)
 - New waterline was put into operation on November 20, 2023, with approval by NYSDOH (Middletown District Office).
 - Original contract work was complete on December 1, 2023, except for punchlist work.
 - Punchlist and remaining work (as of 12/21/23)
 - Complete disinfection testing for Well 1 Complete
 - Site restoration along the route of the water main installation Spring 2024
 - As-Builts Pending
 - Boyd Road restoration of existing roadway surface Complete
 - Boyd Road restoration
 - Roadway additional patching work completed on December 1, 2023
 - \$15,000 in additional NYS OCR funds was approved on November 22, 2023 for partial roadway patching. (See Change Order 1 below).
 - During watermain installation work, the existing surface of Boyd Road was damaged by heavy equipment. Prior to construction, the roadway was in fair condition with a paved surface and some ruts and cracks. The site conditions for the last 1,100 feet of roadway include high groundwater and poorly drained soils. These conditions, coupled with heavy equipment impacts have degraded

- A site meeting with Tweedie Construction, the Town Highway Department, Town Board Member Lennon, and Delaware Engineering was held on November 27 to discuss restoration of existing roadway surface
- At this meeting, it was decided that Tweedie Construction would clean off the roadway surface on 11/30/23 and another site meeting with the Town Highway Dept would be held on 11/30 or 12/1 to decide how best Tweedie can spend the \$15,000 to provide some repairs to damaged sections to best get through the winter.
- On-site meeting held on 12/1/23 and all agreed to patch several areas with hot mix asphalt paving to get through the winter. Hot mix paving patch work complete on 12/1/23.
- See Additional Paving on Boyd Road (plan forward and schedule), below
- The contract completion date was December 1, 2023. (Per Mark Blauer, the deadline for eligible work is January 5, 2024 and the deadline to submit final drawdown requests is <u>February</u> 5, 2024). An OCR extension was granted until June 28, 2024 see below so Tweedie final work and final payment requests can be completed and submitted in May 2024.

Change Order No. 1 – Final Over/Under including \$15,000 for Boyd Road patching

- At the December 4, 2023 meeting the Town agreed to proceed with this change, and the Town Board resolved to authorize the Town Supervisor to execute Change Order No. 1 in the total amount of \$12,207.00, which will increase the cost of the contract to \$403,369.00 (\$391,162.00 plus \$12,207.00).
- The contractor returned the fully executed change order on 12/18/23
- No additional approvals required (i.e., OCR)
- This change order is to address quantity adjustments, for items that were changed during the course of the work, and
 unforeseen items noted during construction. Additionally, a \$15,000 cost increase (pre-approved by OCR) for
 additional road restoration work is included in this change order.
 - A cost adjustment for actual lengths of pipe installed (based on unit prices from the bid) results in a net decrease in contract price of \$11,068.00.
 - Tweedie Construction Services, Inc. has provided a cost of \$5,500.00 for two reinforced concrete anchor blocks which were installed at both ends of the HDPE watermain to prevent movement due to thermal expansion or contraction.
 - Tweedie Construction Services, Inc. has provided a cost of \$2,775 for one hydrant extension which was
 installed on a new hydrant at a point where the new watermain was deeper than anticipated.
- This change order increased the final project cost by a net amount of \$12,207.00, for a new final contract cost of \$403,369.00. The revised cost to finish the project, including retainage, will be \$274,026.68.
- Adequate funds are available to address the additional \$12,207.00 in the existing project contingency. That is, \$183,381 dollars remain in uncommitted funds after this change order.

• At the December 4, 2023 meeting the Town Board resolved to authorize the Town Supervisor to endorse the Certificate of Substantial Completion form for this contract with a date of Substantial Completion of December 1, 2023 and a final contract amount of

\$403,369, including the Punch-list with a total amount of \$39,892. Punch-list amounts to be withheld until all punch-list work has been complete.

- Delaware forwarded the Certificate to the contractor for execution and request project closeout paperwork (i.e., affidavit of release of liens for subcontractors and equipment suppliers, provide maintenance bond, etc.)
- Once all is received from the contractor, we will assemble the project closeout package, and provide it to the Town, with a copy to the contractor.

 At the November 6, 2023 meeting the Town resolved to authorize the Town Finance Department to proceed to process Payment Application No. 2, to General Contract No. TL1-G-22 for Tweedie Construction Services, Inc., for the period ending September 18, 2023, in the amount of \$124,592.32, as requested by the contractor.

Additional Paving on Boyd Road

- On December 1, 2023 Mark Blauer and Delaware reached out to NYS OCR to discuss the possibility of OCR allowing use of some of the remaining uncommitted funds to perform roadway "reconstruction".
- NYSOCR responded that they had no objection to the Town proceeding as proposed, with the following conditions:
 - 1. The Town needs to submit a request for extension through June 28, 2024

 - Based on the cost estimate provided with the extension request, the estimated cost for this work is \$182,225
 - With the Town Highway Department willing to contribute up to \$20,000 toward the road reconstruction/paving work
- On December 14, 2023 NYSOCR sent the Town a letter approving the request for a contract time extension for the above project. See attached.

 The NYS Office of Community Renewal (OCR) is in receipt of the Town of Liberty's letter requesting an extension beyond the project completion deadline of January 5, 2024.

- Based on OCR's review and careful consideration the Town of Liberty's request for an extension has been granted, and your revised project completion date is June 28, 2024.
- This work, and other related expenses (additional engineering, not included in the cost estimate) are anticipated to be covered by the grant
- It is Mark Blauer's opinion that extension approval was not an approval to spend a discrete amount of money. Instead, it was strictly an approval for extra time. - EFC and DOH hosted a webinar on the Lead Service Line (LSL) funding available through the Bipartisan Infrastructure Legislation (BIL).
 - Grants are only available to municipalities that meet the definition of a Disadvantaged Community (DAV). If a client is not a DAV, then they will only get subsidized financing
 - In order to qualify for BIL Lead Service Line grant funding (inventory or replacement), a municipality needs to have a 2021 MHI that is less than 80% of the regionally-adjusted State MHI. The Town of Liberty Qualifies for this.
 - DAV eligibility applies to both inventory and replacement projects. DAVs can get up to 100% grant funding (\$2M max) for inventory projects, and up to 70% grant funding (\$10M max) for replacement projects.
 - You can only apply for LSL replacement funding for locations where the number and location of LSL are known and verified, even if it is just a targeted area. However, if you are requesting replacement funding, then the entire line (public and private portion) must be replaced.
 - You can apply for both inventory and replacement projects simultaneously, but with separate applications. For example, in
 the Village of Catskill there are some known locations of lead service lines associated with a water main replacement project
 that is in the planning stages, but they still need to complete a community-wide LSL inventory before the DOH October

Please consider this letter to be the Town's request for a contract extension for project #641PW78-21 through June 28, 2024.

During December 2023 the Town is using \$15,000 of CDBG Funds for Boyd Road repair work in order to undertake interim repairs of Boyd Road to minimize inconvenience to motorists during the winter of 2023/2024. Once this \$15,000 is spent the Town would close out its contract with Tweedie Construction for water main and well screen installation.

Boyd Road was in just fair condition before water main installation began. The bid package included only trench restoration because the Town did not think the budget would permit shoulder to shoulder resurfacing and because the Town already intended to resurface Boyd Road in Spring 2024 using Town funds (likely cost of \$20,000) to restore the road to a usable condition.

The damage to Boyd Road as a result of the water main installation was far more serious than originally projected. Boyd Road is an area of high groundwater and poorly drainage soils. Such a soft subsurface usually only results in more rapid deterioration under normal traffic conditions but is susceptible to rapid degradation when subjected to construction equipment traffic. Boyd Road has suffered damage that cannot be remedied just by resurfacing. Instead the road will require reconstruction.

Attached is a proposed cost estimate for reconstruction of Boyd Road. The estimate is \$182,225. The Town is prepared to contribute the \$20,000 it originally intended to use for resurfacing for Boyd Road reconstruction.

The reconstruction of Boyd Road we are proposing can be completed by June 28, 2024 in accordance with the attached detailed schedule produced by Delaware Engineering, excerpts of which are summarized below:

Savitry and Charlie

Thank you for giving the Town permission to use the \$15,000 for Boyd Road repair work to get through the winter with minimal inconvenience to motorists.

This morning Dave Ohman of Delaware Engineering is traveling to White Sulphur Springs to look at Boyd Road to determine just how and where to spend the \$15,000 to patch up the roadway till Spring. As matters stand this \$15,000 would be spent in early December and the Town would proceed to close out its contract with Tweedie. A large disbursement would be submitted in mid December. A final disbursement would be submitted in mid January. An unspent balance of around \$190,000 would be de-obligated.

Since your November 22nd email granting permission the Town has reached out to me asking that I make a further request to use remaining funds not already obligated to construction. Even if OCR was agreeable to allowing such work a contract extension into 2024 would be required.

Boyd Road was already in just fair condition before construction began in September. The bid package included only trench restoration because (1) the Town did not think the budget would permit shoulder to shoulder repaving and (2) the Town already intended to resurface Boyd Road in Spring 2024 using its own funds. Our request for the \$15,000 supposed the Town's planned resurfacing in Spring 2024, at a likely cost of \$20,000 in Town funds, would restore the road to a usable condition.

Delaware Engineering is reporting that the damage to Boyd Road as a result of the water main installation is far more serious than originally projected. Boyd Road is an area of high groundwater and poorly drainage soils. Such a soft subsurface usually only results in more rapid deterioration (alligatoring) under normal traffic conditions but is susceptible to rapid degradation when subjected to construction equipment traffic. Boyd Road has suffered damage that cannot be remedied just by resurfacing. Instead the road will require reconstruction.

Attached is a pdf document with four photographs of Boyd Road on November 28th. Also attached is a proposed cost estimate for reconstruction of Boyd Road. The estimate is \$182,225. The Town is prepared to contribute the \$20,000 it intended to use for resurfacing to the effort.

We realize that reconstruction can only occur if it (1) the Town revises its Environmental Review Record, (2) the Town's publish a new NOI-RROF and (3) the Town bids out reconstruction as a separate contract. These tasks could be completed by the end of March 2024. As the asphalt plants only reopen in April in Sullivan County, construction could be completed by the end of June 2024.

As this is the Town's last CDBG project for White Sulphur Springs, and may be its last CDBG project ever, we would like to complete this effort underway since 2014 without leaving neighborhood residents dissatisfied.

The Town is asking for a conference call with OCR to determine if reconstructing Boyd Road is even a possibility as it would require a six month extension. If not possible they would close out the project in January 2024, but at least they would have asked.

RESOLUTION TO JOIN THE SULLIVAN O&W RAIL TRAIL ALLIANCE

WHEREAS, The Town of Liberty contains a section of the former O&W railroad corridor; and

WHEREAS, a portion of the O&W corridor has been developed into a multi-use rail trail that is owned and maintained by the Town of Liberty; and

WHEREAS, the Town of Liberty participated with Sullivan County and other municipalities in the creation of the *Sullivan O&W Rail Trail Feasibility Study* that details recommendations for building out the rail trail ("Trail") in Sullivan County by connecting the existing developed sections to create a 50+/- mile long facility from Mamakating through Rockland, and by creating a new trail along the former O&W spur line traveling south through Monticello; and

WHEREAS, the Town Board of the Town of Liberty recognizes the Trail provides a multitude of community benefits including enhanced quality of life, higher property values, economic development, sales tax revenue, and better public health and that these benefits will increase as the Trail is expanded and improved; and

WHEREAS, the Town of Liberty has been engaged with other Trail municipalities and stakeholders in the implementation of the *Sullivan O&W Rail Trail Feasibility Study*, collaborating on Trail branding, marketing and promotion, clean-up, grant seeking and other activities; and

WHEREAS, the *Feasibility Study* recommends "the creation of a trail coalition...to assist municipalities operating and maintaining the Trail," further recommending that such group be established as a non-profit 501c3 corporation and that members 'should pay dues to fund {its} operations;" and

WHEREAS, Trail stakeholders, including representatives of the Town of Liberty have met to plan for the creation of such a group, determining to establish the Sullivan O&W Rail Trail Alliance ("Alliance") for the purposes of conducting project development, fundraising and grant seeking, maintenance, marketing and promotion, and special events related to the Trail,

NOW, THEREFORE, BE IT RESOLVED, that the Town of Liberty

- 1. Will be a member of the Sullivan O&W Rail Trail Alliance, when established, and hereby acknowledges the terms and conditions of the Alliance Bylaws, including the administrative compliance and audit requirements; and
- 2. Will appoint a representative and alternate to serve on the Alliance Board and to apprise the Town of Liberty Board of Alliance activities and Trail development; and
- 3. Will adhere to the design guidelines and brand guide in the *Sullivan O&W Rail Trail Feasibility Study* when implementing trail expansion and/or improvements; and

BE IT FURTHER RESOLVED, that the Town of Liberty does hereby authorize funding for the Sullivan O&W Rail Trail Alliance in a minimal annual amount, determined by the fiscal health of the municipality and as determined annually during the Town's budget review process. Such funds shall be used for operating expenses, trail marketing and promotion, fundraising and such common maintenance activities as may be determined by the Alliance.

Section III - MEETINGS

The Alliance will typically meet monthly, or as needed, at a date and time decided upon by a majority of the membership. Meetings may be held in person or members may participate by electronic means to facilitate interactive discussions. The Committee Chair will be responsible for chairing all regular meetings of the Alliance and will prepare an agenda before each meeting. In accordance with the terms of the Fiscal Sponsorship Agreement, Catskill Mountainkeeper will be responsible for providing financial statements in advance of each meeting.

Section IV—RESPONSIBILITIES AND DUTIES:

To fulfill its responsibilities and duties, the Alliance shall:

- Coordinate ongoing activities to advance build-out of the trail and assist with researching and securing grants for the benefit of all trail segments as needed.
- 2) Maintain a web site and social media presence, and periodically sponsor events and trail stewardship activities to promote use and awareness of the trail.
- Publish and distribute trail maps and other printed material to promote use and awareness of the trail.
- Review and coordinate with the efforts of other regional advocacy or trail-work groups, including the Pathways Committee of Vision Hudson Valley, to advance the concept of building a region-wide interconnected trails network.
- 5) Maintain minutes or other records of meetings and activities of the Committee.
- 6) Report regularly to the Catskill Mountainkeeper Board of Directors.

Section V—MEMBERSHIP DUES:

To generate revenue in support of the aforementioned activities, an annual request for membership dues shall be made to each voting member of the Alliance. Payment of membership dues shall be strictly voluntary, and any revenue generated will be used primarily for marketing, promotion and trail maintenance activities. The ability and/or willingness to pay membership dues will not affect anyone's standing as a voting member. The annual suggested dues shall be \$500 for Municipal members and \$100 for other members, but any amount is acceptable.

SULLIVAN O&W RAIL TRAIL ALLIANCE ADVISORY COMMITTEE CHARTER

Section I — ALLIANCE PURPOSE:

The Sullivan County O&W Rail Trail Alliance (the "Alliance") is a collaboration between several government entities, non-profit organizations, and individuals in Sullivan County, New York formed for the following purposes:

- 1) To implement the goals and objectives of the Sullivan O&W Rail Trail Feasibility Study;
- To promote regional development and maintenance of sections of the O&W Rail Trail in Sullivan County, NY in partnership with local government;
- 3) To market and promote the O&W Rail Trail through printed and digital media, and organizing events on the trail;
- To raise funds, including soliciting donations and applying for grants, to further the purposes set forth above;

These purposes will be achieved through cooperative participation by Alliance members. The Alliance is organized exclusively for public and charitable purposes and is fiscally sponsored by the Catskill Mountainkeeper Inc. as part of its Fiscal Sponsorship Program. As such, the Alliance is bound by the terms of the Fiscal Sponsorship Agreement annexed hereto as Appendix A.

Section II — ALLIANCE COMPOSITION

The Alliance shall be comprised of 21 voting members as follows:

1) Eleven (11) municipal members, including the Town Supervisors and/or Village Mayors (or their designee) representing the Town of Rockland, Town of Liberty, Village of Liberty, Town of Fallsburg, Village of Woodridge, Town of Mamakating, Village of Wurstboro, Town of Thompson, Village of Monticello, Town of Forestburgh and the County of Sullivan.

2) Ten (10) members from the community at large who share an interest in trails advocacy and building healthy communities, to be agreed upon by a majority of the municipal members, and confirmed by the Catskill Mountainkeeper Board of Directors.

Prior to the beginning of each calendar year, three officers (elected by the advisory committee members) will be chosen to coordinate the Alliance's responsibilities and duties for the upcoming year, as outlined in Section III below. One of the officers will be appointed as Committee Chair to serve as the primary point of contact with Catskill Mountainkeeper, Inc. and to be the official signatory on the Fiscal Sponsorship Agreement. The remaining officers will serve as Co-Chairs.




Whereas It is a recognized civil right in the United States for every citizen to have free and fair elections. "And the right of suffrage can be denied by a debasement or dilution of the weight of a citizen's vote just as effectively as by wholly prohibiting the free exercise of the franchise." (Reynolds *v*. Sims, 377 U.S. 533 (1964))

Whereas It is the affirmative duty of our election officials to comply with all Federal and State laws governing administration and procedure of our elections, thereby guaranteeing our elections are accurate and free from distortion or manipulation. "Congress seeks...to guard the election of members of Congress against any possible unfairness by compelling...everyone concerned in holding the election to a strict and scrupulous observance of every duty devolved upon him while so engaged... The evil intent consists in disobedience to the law." (In Re Coy, 127 U.S. 731 (1888)).

Whereas Our constitutional system of representative government only works when the worth of honest ballots is not diluted by invalid ballots procured by corruption, and assuring accuracy can only be achieved through fealty to those laws governing the following four tenets of an election:

- 1. The Voter Rolls Must Be Accurate (National Voter Registration Act, 1993).
- 2. Votes Counted Must Be From Eligible Voters (US Constitution, Fourteenth Amendment).
- 3. The Number of Votes Counted Must Equal the Number of Voters Who Voted.
- There Can Be No More Than One in 125,000 Ballots in Error by the Voting System (Help America Vote Act, 2002).




- **5,142,950** ineligible or uncertain registration violations found within the NY State voter roll database.
- 732,359 votes cast by ineligible or uncertain registrants.
- **35,312** more votes counted than voters who voted in the 2022 general election. No one knows who cast them.
- **745,246** apparent voting violations in excess of the legal standard of system accuracy for a valid federal election. For the 2022 election in New York this number was **48**.
- Certification as defined by law, an attestation of accuracy and compliance, appears to have been fraudulent and illegal.

Whereas These findings trample accuracy requirements of voting systems for a Federal Election, wherein the system shall achieve a target error rate of no more than one in 10,000,000 ballot positions, or one in 125,000 ballots. For a voting system, accuracy is defined as the ability of the system to capture, record, store, consolidate and report the specific selections and absence of selections, made by the voter for each ballot position without error.

Reveas It must be known factually, and provably, that the intent of the voters is accurately represented by election results before certification can be lawfully conducted. Certification of an election that varies from the law is an abridgement of the civil rights of the citizens, a Fraud ab Initio. (United States *v*. Throckmorton, 98 U.S. 61 (1878)).

Audit to seek redress for these egregious violations with indifference and inaction, including the Attorney General, Secretary of State, State Board of Elections, Inspector General, Federal Bureau of Investigations, State Leadership of Democrat and Republican parties, County Election Officials, Sheriffs, District Attorneys, and others.

Whereas None of the reported 2020 violations were addressed prior to the administration and certification of the 2022 General Election, and there prevails a spirit of extreme contention and zero trust between people of differing political ideologies across New York, which is destructive to our families, our way of life, and the fabric of these United States.



 A complete end-to-end audit, from registration through certification, of the New York State 2022 General Election, for both paper and electronic records, including ballots, by a mutually agreed upon external, third-party bonded auditing firm, possessed of adequate insurance and indemnification for the handling and protection of the personal identifying information of millions of New York citizens, in order to determine the true error rate. This audit will provide a comprehensive report and analysis of all lapses and errors with explanation of cause where it can be determined.

2. The enactment of legislation defining a mutually agreed upon process by which an end-to-end audit would be triggered in any future elections.

- **3.** The enactment of legislation defining a mutually agreed upon accuracy rate for the voter roll databases.
- 4. The enactment of legislation allowing for anonymous vote verification and tracking by the voter (open-source, royalty-free patent pending), including automatic mechanisms to report and remedy errors during the canvass period following an election, regardless of ballot entry source.
- **5.** Criminalize election misconduct explicitly with regard to State election law, and increase penalties to reflect the societal and generational harms inflicted by these crimes.

Audit is a citizen's group organized for the purpose of performing an open-source audit of the New York State Board of Flections.

The three basic tenets of an election:

- Voter Rolls must be accurate.
- Votes counted must be from qualified voters.
- The number of votes counted must equal the number of voters who voted.

Findings:

(as presented in the attached full report, "A Study in Deficits")

- 2,427,827 NYSVoter ID numbers attached to 1,170,790 registrants (p. 2)
- 987,490 voters registered on January 1st from 1900 to 2021 (p. 3)
- 1.9M registrations in the state voter rolls missing from the county rolls (p. 4)
- 625,359 more registrations than voting-age citizens in just six counties (p. 4)
- 740,396 apparently ineligible votes statewide (p. 8)
- 338,356 more votes counted than voters who voted in 2020 (p. 10)
- 195,271 votes cast in NYC that went missing in the NYSVoter database (p. 11)

Conclusions:

- Over 1,000,000 apparent felony violations of NYS Election Law.
- 95 State and Federal legislative races impacted by 740,396 apparently ineligible votes.
- The NYSBOE, whether by dereliction of duty or deliberate malfeasance, appears to have materially affected election outcomes in NY. A full end-to-end audit by professionals and possibly law enforcement is warranted.

New York Citizens Audit is a citizen's group organized for the purpose of performing an open-source audit of the 2020 General Election in New York. The following report focuses on the three basic tenets of an election:

- 1 Voter rolls must be accurate,
- 2 Votes counted must be from qualified electors,
- 3 The number of votes counted must equal the number of voters who voted.

VOTER ROLLS MUST BE ACCURATE

Researchers from New York Citizens Audit (NYCA) examined voter rolls provided by the New York Board of Elections (NYSBOE), as well as voter rolls provided by the county BOEs (where these were granted), pursuant to freedom of information law (FOIL) requests. New York State election law provides clear guidance regarding the qualifications for a person to register to vote:

Election (ELN) CHAPTER 17, ARTICLE 5

§ 5-102. Qualifications of voters; age and residence.

 No person shall be qualified to register for and vote at any election unless he is a citizen of the United States and is or will be, on the day of such election, eighteen years of age or over, and a resident of this state and of the county, city or village for a minimum of thirty days next preceding such election.

§5-204. Local registration; General Provisions for the Conduct of.

- b. If the applicant's name does not appear on the list of registered voters and if the applicant is not challenged, and he is found by the inspectors of election to be otherwise qualified, they shall complete his registration as provided herein.
 - c. If the person's name appears on the list of registered voters and he is residing at the same address as set forth therein, his registration shall be refused as unnecessary.

Additionally, New York State election law makes clear what elements comprise a complete registration record:

§ 5-500. Registration records; form and content.

- 4. The central file registration records and the face of the registration poll records shall contain a space for the voter's signature, preceded by the words, "The foregoing statements are true", and followed by the signature of the two members of the board of inspectors or central registration board by whom the voter is registered. In addition, there shall be spaces for the following entries, all of which shall precede the space for the voter's signature:
 - a. Serial number assigned to voter and county of registration;
 - b. The voter's surname, given name and initials of other names;
 - c. The date of registration;
 - d. The residence address at which the voter claims to reside and post office address, if not the same; and the number or designation of the room, apartment, or floor occupied by the voter if he or she does not claim the entire building as his or her residence;
 - e. The assembly district or ward and the election district in which such residence address is located;
 - f. The length of the voter's residence in the county or city calculated to the time of the next general election;
 - g. Whether the voter has previously voted or registered to vote and, if so, the approximate year in which he last voted or registered and his name and address at the time;
 - h. His date of birth;
 - i. A space for the applicant to indicate whether or not he is a citizen of the United States;
 - j. The gender of the voter (optional);
 - k. The telephone number of the applicant (optional);
 - 1. Whether the voter was challenged;
 - m. A space for the applicant to indicate his choice of party enrollment, with a clear alternative provided for the applicant to decline to affiliate with any party.
 - n. On the face of each registration record there also shall be spaces appropriately entitled, for entering information about the cancellation of registration, the date of such cancellation and the reason therefor, and the signature of the two members or employees of the board, representing different political parties by whom the cancellation was recorded;
 - p. A space for pre-registering applicants to respond to the following question: "Are you at least 16 years of age and understand that you must be 18 years of age on or before election day to vote, and that until you will be eighteen years of age at the time of such election your registration will be marked 'pending' and you will be unable to cast a ballot in any election?".

1. VOTER ROLLS MUST BE ACCURATE

IRREGULAR REGISTRATION

Despite the simple delineation under New York election law of voter qualifications, and the elements of a complete registration record including those that are considered "optional", NYCA researchers found the following irregular registrations in the NYSBOE voter rolls (registrations identified as "ineligible" or "eligibility uncertain" are collectively described as "irregular" in this document):

Registrations made on federal holidays

NYCA identified:

- 1,106,646 registrations in the voter rolls made on federal holidays, for which there is no known explanation.
- 640,792 of these were registered for the 2020 general election, and
- 365,737 of these voted in the 2020 election.

New Year's Day is a federal holiday. All non-essential government offices are closed on this day. Should it fall on a weekend, when offices are closed anyway, the holiday is observed on the following Monday. Regardless, the NYSBOE voter rolls record **987,490** January 1st registrations across various years, from before the year 1900 through 2021. There are **202,573** January 1st registrations in Kings County. Other New York City counties come close, as shown below. Most New York counties have fewer than 10 registrations on this date, such as Chenango, which has 1.

An accurate registration date is material to determining a voter's eligibility to vote in any given election. An invalid date makes it impossible to determine if the voter was eligible to vote during any election for which a vote was recorded.

National Change of Address and Non-Citizens

Categories of known irregular registration that are not accounted for, as of publication, include individuals labeled in the national change of address (NCOA) database as having moved, and registrations assigned to non-citizens. NYCA is not able to access citizenship records. Recent coverage in the *New York Post* indicates this is a category that should be investigated, however. 63-year-old Abdul Rahman Kargbo, a non-resident green card holder, claims he never registered to vote. Yet he has a voter registration record and, according to the NYSBOE, has voted multiple times over 13 years (https://nypost.com/2022/09/17/manhattan-immigrant-was-voting-illegally-for-13-years-boe/). In the article, a NYCBOE whistleblower asserts there "could be thousands" of illegal voters currently registered and voting.

1. VOTER ROLLS MUST BE ACCURATE

State and County voter roll agreement

NYCA researchers correlated registered voters between state and county voter rolls. This analysis was limited to 7 counties. Correlation was deemed impossible upon discovery of the following discrepancies:

This significant problem appears impossible under NY election law:

§ 5-614. Statewide voter registration list.

- The official statewide voter registration list shall be created by combining the existing voter registration list maintained by each local board of elections into a single integrated list.
- 4. Adding, changing, canceling or removing voter registration records shall be conducted only by local boards of elections as provided by this chapter.

Over-registration

Further confounding accuracy of the NY voter rolls was the revelation that six New York state counties had in excess of 100% voter registration during the 2020 general election, as compared with their official state reported population by age, and 51 additional counties had over-registration in certain age categories, resulting in an apparent minimum of **625,359 excess registrations:**


SUMMARY

It is impossible to describe voter rolls which contain irregular registrations in the millions as "reasonably accurate." Irregular registrations are present in state and county voter rolls. These registrations may not represent unique eligible voters. There are no innocent explanations known to NYCA that can adequately explain them. NYSBOE and county BOE voter rolls appear to be in significant violation of the Help America Vote Act of 2002:

H. R. 3295, TITLE III, Subtitle A—Requirements

SEC. 303. COMPUTERIZED STATEWIDE VOTER REGISTRATION LIST REQUIREMENTS.

- (a) COMPUTERIZED STATEWIDE VOTER REGISTRATION LIST REQUIREMENTS .-
 - (4) MINIMUM STANDARD FOR ACCURACY OF STATE VOTER REGISTRATION RECORDS.— The State election system shall include provisions to ensure that voter registration records in the State are accurate and are updated regularly, including the following:
 - (A) A system of file maintenance that makes a reasonable effort to remove registrants who are ineligible to vote from the official list of eligible voters.



IRREGULAR REGISTRANTS THAT "VOTED"

Using NYSBOE voter rolls provided on October 21, 2021, "the official statewide voter registration list" according to § 5-614, NYCA counted the following votes assigned to irregular registrations in the general election of November 3, 2020:

Name and address are curable at polling sites

According to § 8-302 of NYS election law, some of these defects could have been cured at the polling site. These include an address update or name change. In order to accept an address update, the following procedure must be implemented:

3. (b) A person who claims to have moved to a new address within the election district in which he or she is registered to vote shall be permitted to vote in the same manner as other voters unless challenged on other grounds. The inspectors shall enter the names and new addresses of all such persons in either the first section of the challenge report or in the place provided in the computer generated registration list and shall also enter the new address next to such person's address on such computer generated registration list. When the registration poll records of persons who have voted from new addresses within the same election district are returned to the board of elections, such board shall change the addresses on the face of such registration poll records without completely obliterating the old addresses and shall enter such new addresses and the new addresses for any such persons whose names were in computer generated registration lists of such persons.

In order to accept a name change update, the following procedure must be implemented:

(c) A person who claims a changed name shall be permitted to vote in the same manner as other voters unless challenged on other grounds. The inspectors shall either enter the names of all such persons in the first section of the challenge report or in the place provided in the computer generated registration list, in the form in which they are registered, followed in parentheses by the name as changed or enter the name as changed next to such voter's name on the computer generated registration list. The voter shall sign first on the registration poll record or in the computer generated registration list, the name under which the voter is registered and, immediately above it, the new name, provided that in such registration list, the name may be signed in the place provided. If a voter has signed a new name in a computer generated registration list, such board shall enter such voter's new name and new signature in such voter's computer record.

The election was certified as accurate and compliant with significant inaccuracies in the voter rolls, each representing an open question regarding compliance.

Affidavit Ballots

Similarly, there are cures that can be effected at the polling site with an affidavit ballot. One example is a blank address. NYCA requested the list of affidavit ballots from each county BOE, along with the reason for its use. One example of how affidavit ballots do not provide an adequate explanation for the irregular votes comes from Steuben County:

There are simply not enough affidavit ballots from the 2020 general election to cure the irregular votes.

Purged registrant cures

No procedure is given under the law to allow a purged registrant to vote. Every purged registrant that voted is an open question for which a documented audit trail must be provided, proving legitimacy.

The outcome of many races is an open question due to the 740,396 irregular votes

NYCA analyzed the impact of these irregular votes on election outcomes by district, including Congressional district, NYS Senate district, and NYS assembly district. Here is the result by Congressional district:

** If the "**N**" is red, the number of irregular votes exceeds the margin of victory. If the "**N**" is blue, the number of irregular votes exceeds 50% of the margin of victory. There is no way to know how irregular votes were cast. In the case where the irregular votes are subtracted from the "winner" and added to the "loser," the outcome would have been opposite; therefore the outcome is unknown and should never have been certified. NYCA is non-partisan and has no preferred candidates.

2. VOTES COUNTED MUST BE FROM QUALIFIED ELECTORS Irregular Registrants that "Voted"

NYCA analysis of the 2020 general election NYS Senate and Assembly races, conducted in an identical manner to the Congressional table on the previous page, concludes that **38% were seemingly uncertifiable**:

- Seemingly uncertifiable NYS Senate races, by district, 24 out of 63 total: 1, 3-7, 9, 15, 37-43, 45, 46, 50, 51, 53, 55, 56, 58 and 61.
- Seemingly uncertifiable NYS Assembly races, by district, 60 out of 150 total: 1-4, 9-17, 19-21, 23, 26, 46, 61, 63, 64, 76, 94, 98, 99, 101, 102, 104-108, 110-122, 124-127,131-133,135, 140, 143-146 and 148.

SUMMARY

Votes cast by ineligible registrants are election fraud. In the financial sector, the discovery of any amount of potential fraud triggers a full investigative audit of the reported figures (see "Threshold of Materiality" in section 5, conclusions). The NYSBOE, whether by dereliction of duty or deliberate malfeasance, is unquestionably responsible for impacting election outcomes in NY, with consequences of as yet unknown magnitude. Only a full end-to-end audit, from registration through certification, by professionals and possibly law enforcement, would be able to provide that conclusion.

THE NUMBER OF VOTES COUNTED MUST EQUAL THE NUMBER OF VOTERS WHO VOTED

NYCA researchers compared reports from various official NY state sources, regarding the 2020 general election vote and voter counts. The comparisons below are based on data downloaded from the NY Secretary of State (NYSOS) website, voter rolls provided by NYSBOE, voter rolls provided by 43 counties, and reporting from NY election precincts.

NYCA identified discrepancies in every comparison:

* The max discrepancy is calculated based on the max discrepancy per county, where the greatest discrepancy between 2 sources in one county is different from the 2 sources that yield the max discrepancy in another. The max discrepancy between any 2 sources for the state is between the count of certified votes provided by the Secretary of State and the number of 2020GE votes recorded in the NYSBOE voter roll (272,439 votes).

The fact that a completely unexplained discrepancy between official sources, of 338,356 votes, stands as the certified result of New York's 2020 general election is shocking. No one knows who cast those votes. It is not clear how the various sources differ, since each ostensibly relies on the other as its source. Regardless, **NY officials appear to have certified an election** with **338,356 more votes cast than voters who voted, contrary to the law.**

NYCA was able to find one law in NY that addresses the question of procedure regarding discrepancies:

§ 9-108. Canvass; ballots, verifying number cast.

2. If the ballots found in any box shall be more than the number of ballots so shown to have been deposited therein, such ballots shall all be replaced, without being unfolded, in the box from which they were taken, and shall be thoroughly mingled therein, and one of the inspectors shall, with his or her back to the box, publicly draw out as many ballots as shall be equal to such excess and, without unfolding them forthwith shall enclose them in an envelope which he or she shall then and there seal and endorse "excess ballots for the general election, presidential electors, or party ballots or otherwise", as the case may be, and shall sign his or her name thereto, and place such envelope in the box for defective or spoiled ballots.

Thankfully, this law allowing the indiscriminate disposal of voted ballots was not completely followed in regards to the 2020 general election, and 338,356 voters were not disenfranchised without a trace. The question of "Who cast what?" remains.

Every county in NY was affected by these discrepancies, but none more so than the five boroughs of New York City:

Missing Votes

Voter rolls maintained by the NYCBOE, as well as Dutchess and Onondaga Counties, show **195,271** votes cast in the 2020 general election that are not recorded in the NYSBOE voter rolls.

Voter rolls maintained by the NYSBOE show **28,369** votes cast in the 2020 general election, in Erie and Nassau counties, that are not recorded in the voter rolls maintained by the corresponding county.

There is no innocent explanation for these discrepancies.

SUMMARY

Discrepancies between various official vote counts are irreconcilable. The remedy for this is to not certify any vote counts that are so affected, or to decertify or nullify any affected election that was certified previously.

VERIFICATION METHODS

NYCA researchers have used a variety of strategies to verify these findings, using open source information only.

Illegal Duplicates

Much of this effort has centered around seemingly Illegal Duplicate registrants, whose identities have been used to create unlawful official documents without their knowledge. A number of things must occur before an individual voter can have multiple identification numbers and votes assigned to their personal information:

- 1. An "original record" must be made, often legitimate and connected to a real voter.
- The original record must be duplicated (illegally) by someone with official access, or using software installed by someone with official access (§170.10 forgery in the second degree, §190.80 identity theft in the first degree, 18 U.S. Code §1028A Aggravated Identity Theft, and §17-160 Procuring fraudulent documents in order to vote).
- 3. The illegally duplicated record(s) must be entered into the voter roll by someone with official access, and assigned a unique SBOEID (§17-104 False registration, §17-106 Misconduct of election officers).
- 4. A vote must be assigned to the replicated record(s) by someone with official access (§17-132 Illegal voting).

Each registrant, under NY law, must have a registration application document on file, bearing their signature. Using the FOIL process, NYCA requested a set of these application documents, specific to the suspected illegal duplicate registrants identified, from the BOE in each county.

Each responded in a slightly different way but their responses have one thing in common: they either do not supply records for suspected illegal duplicate registrations, or the records they do supply appear to be photographic replicas of forms assigned to other SBOEID numbers thought to be the illegally duplicated source.

For instance, if you have a legitimate voter "John Doe #1", there will be a legitimate registration application form and SBOEID number in his name. If his data is illegally duplicated, there will be a second SBOEID number and digital record in his name, but there will not be a second application form with signature for John Doe #2. The way counties have responded is consistent with this scenario. They provide records for John Doe #1 in every case. For John Doe #2, they either claim they don't have access to the record, or they present a variation of John Doe #1's record, usually a photographic duplicate of the signature attached to a "voter record" (not the application form).

Last, some counties have made tacit admissions that the records in question are seemingly illegal duplicates. They did this by purging the records as duplicates after receiving our FOIL request. This is usually 2 years or more after the registration was created and given active status. Many of them were used to vote.

It is NYCA's belief that no genuine signed voter enrollment applications exist for these seemingly illegal duplicate registration records.

VERIFICATION METHODS

Canvass

NYCA has used these seemingly forged documents, as well as the original information from the NYSBOE voter rolls, to canvass the suspected illegal duplicates, who may have had their identities stolen from within the NYSBOE. In hundreds of addresses visited, there have been no false positives. Instead, in the process of canvassing, other apparent violations have been uncovered including falsified registration dates, illegal votes cast, and the removal of votes legitimately cast. Sworn affidavits attest to each of these discoveries.

In fact, the discovery during canvass that parts of a registration record are inaccurate has become so "normal," that NYCA no longer considers the "official statewide voter registration list" to be reliable at all. If an entry in the voter rolls for any given voter is proven to be false, impossible, or irreconcilable with other official records, that portion of the record is false. To be false, it has been falsified, regardless of the reason. A falsified record is invalid.

An accurate voter registration record is material to determining whether legitimate votes were diluted by fraudulently cast ballots, whether votes were correctly tallied, and if state and county election officials have faithfully followed election law.

In two especially egregious cases of apparent identity theft, one where the registrant was assigned 11 SBOEIDs in a 48 hour period, the other assigned 21 SBOEIDs in a 24 hour period, all to the exact same name, DOB, and address, every one of the registrations was found to be false. In the first instance, canvassers found a single homeowner who had been living at that address for decades, long before the registrations were created, and had no knowledge of the registrant. In the second instance, there was similarly no trace of the "voter" at that residence.

SUMMARY

NYCA has accurately assessed problems of irregular registration and voting during voter roll analysis. Verifying our suspicions has only led to an increase in known irregularities.

CONCLUSIONS

The three basic tenets of an election:

- Voter rolls must be accurate,
- 2 > Votes counted must be from qualified electors,
- 3 > The number of votes counted must equal the number of voters who voted,

were all significantly violated in the certification of the NY 2020 general election.

NYCA has already demonstrated that this resulted in the possibly false certification of 95 state and federal legislators, without examination of ballots or investigation of suspicious persons and activities, of which NYCA has received many reports. NYCA has also demonstrated that every race statewide was potentially marred by election fraud.

Threshold of materiality

The standard for auditing in accounting and finance is called the "materiality threshold". If a misstatement concerns 5% or less of a company's net income, it is considered not material, and no audit is performed. If it concerns 10% or more, it is considered material. For amounts between 5%-10%, it is a judgment call for the auditor. However, according to the Securities and Exchange Commission's guidelines, any misstatement is material if "the misstatement involves concealment of an unlawful transaction."

Investigation of NY voter rolls by NYCA, and lack of compliance from some county officials, suggests that election officials may have created systemic fraud within NY elections, which may have resulted in the unlawful alteration of election outcomes. For that reason, the stricter accounting industry threshold of materiality should be used instead of the "exceeds the margin of victory" threshold. According to that standard, no election with demonstrable fraud, or which was administered by officials who demonstrated clear dereliction of duty, should have been certified without an investigation of the apparent anomalies.

AN END-TO-END AUDIT OF NYSBOE IS WARRANTED

NY Citizens Audit volunteers have presented the facts contained in this report, as known to us on May 9, 2022, in petition form to the NY Attorney General, NYSOS, NYSBOE Commissioners, and the leaders of the Republican and Democrat parties. No response was received. Petitions sent to the SOS were returned.



NY Citizens Audit volunteers met with investigators at the NY State Police to present the facts contained in this report, as well as other sensitive findings, on June 27, 2022. The materials presented were passed to the Foreign Intelligence Task Force of the FBI. No response was received.

NY Citizens Audit volunteers met with sheriffs in 5 counties to present this information, as well as a special report regarding the 308,887 cases of apparent identity theft within the NYSBOE. One investigation was launched, the scope of which is unknown to NY Citizens Audit. The majority of sheriffs contacted have refused to meet with NY Citizens Audit. Some of them have claimed they are simply too busy dealing with surges in violent crime, which could well be the result of policies implemented by false representatives, including District Attorneys, Mayors, and others whose races NYCA has not yet analyzed.

The miracle that a small group of determined citizens uncovered this abject mess must not be ignored, and indeed NY Citizens Audit is doing everything possible to ensure that every official across NY is made aware of these facts, as well as every citizen, and the crisis in governance that has resulted. The NYSBOE must be audited end-to-end, from registration through certification.

Disclaimer: Results presented are based on a good faith effort to accurately analyze and report on the NY State voter rolls provided to NY Citizens Audit on 10/12/2021 and the voter information provided by various counties in NY. Some values and statements may change as we gain a deeper understanding of these data.

Our US Congress recognized in 1993 that in order to secure government by consent, the principle of American liberty and justice upon which our constitutional republic was founded, the electoral process must be protected by maintaining accurate voter rolls:

52 USC 20501 (National Voter Registration Act of 1993.)

SEC. 2. FINDINGS AND PURPOSES.

- (a) FINDINGS—The Congress finds that—
 (1) the right of citizens of the United States to vote is a fundamental right;
- (b) PURPOSES—The purposes of this Act are—
 - (3) to protect the integrity of the electoral process; and

(4) to ensure that accurate and current voter registration rolls are maintained.

Congress was right. A voter registration record is granted a ballot. Eligibility must be verified before any applicant can be registered. Maintenance of registration lists must be scrupulous. If a name appears on the list of registered voters, it is presumed to be legitimate, and allowed to cast a vote.

"Accurate" as defined in Merriam-Webster dictionary:1: free from error especially as the result of care2: conforming exactly to truth or to a standard3: able to give an accurate result

INVALID REGISTRATION IN NEW YORK'S VOTER DATABASE

Through inspection of the voter rolls⁴ in New York State, NY Citizens Audit has discovered they are so inaccurate, the circumstance is described under the law as a total "Loss of Control."⁵ Federal and state laws regarding registration are simply ignored. Millions of examples exist. Regardless of blanket excuses and denials from election officials, these appear to be invalid or illegal registrations. Crimes against the elective franchise are being committed. Either the records are improperly maintained, or the certification is false. Under federal prosecution guidelines, either one is a crime.

Here is a sampling of registration records from the New York State voter roll database (NYSVoter) as of December 19, 2022 that are seemingly invalid or illegal. Some of them could be given an affidavit ballot to vote at an in-person polling site under state law, if a proper cure is presented. Although their presence in the database violates the federal principle of accuracy due to ineligibility, current state law excuses that.

ILLEGAL DUPLICATE REGISTRATIONS

Illegal duplicates are new registrations based on a particular voter who already has a record in the database. So now we have two or more unique voters who are really the same. This creates the opportunity for multiple votes to be cast by, or assigned to, the same identity. In some cases the original registration is real and verifiable by direct canvass. In other cases the original is unverifiable by direct canvass or other means; the "voter" appears to be fictitious.

FEDERAL LAW IS CLEAR ABOUT "DUPLICATE" REGISTRATIONS IN THE VOTER ROLL DATABASES:

52 USC 21083 (Help America Vote Act of 2002)

SEC. 303. Computerized statewide voter registration list requirements and requirements for voters who register by mail.

- (a) computerized statewide voter registration list requirements
 - (1) Implementation
 - (A) in general—Except as provided in subparagraph (B), each State, acting through the chief State election official, shall implement, in a uniform and nondiscriminatory manner, a single, uniform, official, centralized, interactive computerized statewide voter registration list defined, maintained, and administered at the State level that contains the name and registration information of every legally registered voter in the State and assigns a unique identifier to each legally registered voter in the State.

EARLIER LAW ALSO ADDRESSES DUPLICATE ENTRIES IN VOTER ROLL DATABASES:

52 USC 20504 (National Voter Registration Act of 1993.)

SEC. 5. Simultaneous application for voter registration and application for motor vehicle driver's license.

(c) forms and procedures.

- (2) The voter registration application portion of an application for a State motor vehicle driver's license—
 - (B) may require only the minimum amount of information necessary to-
 - (i) prevent duplicate voter registrations.

NEW YORK ELECTION LAW AGREES THAT EACH VOTER GETS ONE REGISTRATION:

NYS Election Law §5-614.4

There shall be one official record of the registration of each voter. Such record shall be maintained in an interactive, statewide, computerized, voter registration list. Such statewide voter registration list shall constitute the official list of voters for the state of New York.

NYCRR 6217.1

(b) NYSVoter shall maintain one record for each voter including the statewide unique identifier.

NYCRR 6217.5

(e) NYSVoter shall assign a unique identifier to every voter that will remain with that voter for their voting life.

New York State board of elections excuses 1,467,399 illegal duplicate registrations

In an official document targeting the efforts of NY Citizens Audit, "False Claims Explained,"⁶ The New York State board of elections (NYSBOE) implies that these federal and state laws *are not actually law*. An excuse is given to dismiss concerns about the board's seeming disregard of election law. The lack of audit records demonstrating the veracity of the excuse is notable, given it is part of an election official's sworn, affirmative duty to provide evidence proving their work meets the legal standard. The excuse does not address cases like A. Piamenta, an unverifiable "person" who has eleven simultaneously active registrations at a single address where he is unknown and has apparently never lived. In short, the excuse is unconvincing. Below is the excuse as provided by the NYSBOE in "False Claims Explained":

Duplicated Voter IDs

Each voter in New York is assigned both a state voter ID and a county ID. Although the state database is designed to have a single state ID follow a voter as they move from county to county, it is possible for multiple reasons that a voter may have multiple records with different state IDs. For example, if a voter registered more than once using the DMV's online portal creating a duplicate record, their duplicate record may be purged, which would show the same voter and name with two voter IDs. One record would be active and the second would be purged.

When NY Citizens Audit researchers searched the NYSVoter database as provided on December 19, 2022, we found 1,467,399 illegal duplicate registrations. To find out if they voted, please turn to page 7, "Votes counted must be from qualified electors."

In the official DOJ publication, "**Federal Prosecution of Election Offenses**, Eighth Edition, December 2017," the following federal crimes are identified:

- Submitting fictitious names to election officers for inclusion on voter registration rolls, thereby qualifying the
 ostensible voters to vote in federal elections (52 U.S.C. §§ 10307(c), 20511(2)).
- Providing false information concerning a person's name, address, or period of residence in a voting district to
 establish that person's eligibility to register or to vote in a federal election (52 U.S.C. §§ 10307(c), 20511(2)).
- Placing fictitious names on the voter rolls. This "deadwood" allows for fraudulent ballots, which can be used to stuff the ballot box.

The law identifies each of these 1,467,399 illegal duplicate registrations as both illegal and suspicious.

The New York State board of elections must provide a line-by-line verification detailing how each one of them was created, as well as the computer audit logs demonstrating every update to voter history. These records have been requested by NY Citizens Audit via Freedom of Information Law (FOIL), and access has unlawfully been denied.

PURGED RECORDS THAT WERE NEVER ACTIVE

NY Citizens Audit discovered 712,360 voter registration records in NYSVoter that were never active.

At the time each record was created, it was given purged status. This is a conundrum, as a purged voter cannot get a ballot under any circumstance. Why, then, did these "people" register?

These 712,360 records appear to be fraudulent. How they may have been used, exactly, remains unknown. Again, the New York State board of elections must provide a line-by-line verification detailing how each one of them was created, as well as the computer audit logs demonstrating every update to voter history.

INEXPLICABLE CHANGES TO THE VOTER ROLLS

NY Citizens Audit used three uniquely dated copies of NYSVoter to run a comparison, line-by-line, of anomalous changes to the database. One copy is dated 10/21/2021, the second 10/24/2022, and the third was received on 12/19/2022. The results are inexplicable and possibly illegal:

Each one of these changes would need to be manually done, based on a legitimate request by the voter, at the local board of elections where the voter resides. This would be an average of 680 illogical registration changes per business day, statewide. The boards of elections must produce every one of these record update requests, submitted by each unique registrant, in order for this finding to be believed lawful.

1. VOTER ROLLS MUST BE ACCURATE

TOTAL LOSS OF CONTROL

In the spring of 2022, NY Citizens Audit Director of Research, Andrew Paquette, PhD, observed and began reverseengineering algorithmic patterns in the assignment of state and county voter ID numbers within NYSVoter.

On June 27, 2022, with the support of the team, this work was reported in person to the New York State Police Special Investigations Unit. The report was considered credible and disturbing, and the inquiry passed to the Foreign Intelligence Task Force of the FBI, which oversees investigation of national security risks to our voting systems.

On May 1, 2023, NY Citizens Audit presented the completed research on these algorithms to the New York State legislature election committees, at the Legislative Office Building in Albany, room 711A.⁷

On May 16, 2023, Paquette published a peer-reviewed scientific research paper, "The Caesar Cipher and Stacking the Deck in New York State Voter Rolls," describing the algorithms, in the *Journal of Information Warfare*⁸. Three independent cyber-intelligence experts agreed that the research was sound, and the database is embedded with steganographically masked (hidden in plain sight) algorithms controlling the assignment of ID numbers.

This is blatantly illegal, and considered a total Loss of Control data breach by the Cybersecurity and Infrastructure Security Agency, the federal agency with the duty to protect critical national cyber infrastructure.

Neither the FBI, nor the legislators, nor any other officials have responded, despite having been presented credible evidence of an existing national security breach within our voting system. It may be misconduct to ignore the report; each of these people swore an oath to protect and uphold our US Constitution.

The breach may explain some of the invalid data discovered by NY Citizens Audit. There is a possibility that the manipulation has been accomplished without knowledge of or participation by any New York election official. However, the state board of election's choice to defend millions of apparent material violations of clear election law, and refusal to meet with honest citizen investigators, does not inspire trust. A full investigation must be launched immediately to determine the source of this active, confirmed, illegal attack compromising the validity of our elections.

"Free and honest elections are the very foundation of our republican form of government. Hence any attempt to defile the sanctity of the ballot cannot be viewed with equanimity." *United States v. Classic, 313 U.S. 299 (1941)*

VOTES COUNTED MUST BE FROM QUALIFIED ELECTORS

Summary of votes cast in New York's 2022 general election by ineligible and uncertain registrations

These numbers were summed from a copy of NYSVoter dated 12/19/2022, *after* state level certification attested to the accuracy and legal compliance of the election. A blank address or unverified registrant could be allowed to vote in person after presenting ID, using an affidavit ballot. It is unknown at this time whether these 20,448 specific records were thus cured before voting. NY Citizens Audit can confirm that procedure was not universally followed in 2020; votes were cast by similarly invalid records for which there was no evidence provided, upon FOIL request, of curing.

January 1st Registration Votes

Two categories of ineligible or uncertain registration clearly dwarf the pool of suspicious votes: illegal duplicates and January 1st registration dates. Again in "False Claims Explained," the state board of elections has provided an excuse for registrations created on federal holidays, 94% of which fall on New Years day:

Voters Registered on Federal Holidays

Voters that are pre-registered to vote will have their record activated on the day of their 18th birthday regardless of whether that date is a holiday. Additionally, if records did not have a registration date stamp when entering the voter into the electronic system, counties may have used January 1st as a placeholder day.

The "placeholder date" excuse attempts to cover provably false data in the voter rolls. Registration dates are material to determining eligibility to vote. When dates are false, the true date is unknown, and eligibility cannot be certain. Further, this does not explain why January 1st registration dates are assigned special ID numbers occupying key positions in the voter roll algorithms that Andrew Paquette, PhD, reverse engineered, uncovering a highly complex and deliberate pattern with no plausible, innocent explanation.

The following chart shows the first 24 rows of New York County data within NYSVoter, exactly as they originally appeared upon receipt of the data. Close inspection reveals that every tenth registration has:

- 1. an alphanumeric county ID number, unlike the other 9 in each set of 10;
- a nearly consecutive state ID number, "short ID," suggesting uniformity and nearly synchronous registration;
- 3. a registration date of 1/1/1984, twenty years earlier than the other 9 in each set of 10.

Given this array of contradictory characteristics, and the loss of control data breach, the "placeholder" date excuse is not plausible. Each of the January 1st registrant votes appears strongly linked to provable fraud.

THE VOTES OF ELECTIONS PAST

NY Citizens Audit has discovered several types of inexplicable data manipulation including missing votes and blank votes. The motive for these illegal changes is unknown. Each category requires immediate investigation.

Missing Votes:

According to NY election law, county and state voter rolls are real time replicas. The counties manage all registration records, and the state database is a compilation of each county's accurate rolls. The following data sets were extracted from official records received via FOIL request:

According to this data, there is a very real possibility that 254,713 voters were disenfranchised by the boards of elections. The NYSVoter database is considered the official record for administering federal elections, including voter history data. The state board of elections must provide a line-by-line audit regarding each of these unique voters, and prove what happened to their votes.

Blank Votes:

Another category of data manipulated post-certification is the count of blank ballots by county.⁹ Two counties stand out as having likely violations in this category, due to the magnitude of injections and subtractions. Although Westchester technically adjusted their data on the date of state certification, apparently squeezing in under the deadline, counties are required to turn their certified data over to the state at least a week in advance of that deadline for state attestation of accuracy and compliance. Additionally, it is unknown how Westchester could have legitimately tabulated over half a million blank ballots.

When \$35,312 goes missing from your bank account, is that a clerical error?

The New York State board of elections publishes an official results document on their website after every election. It includes the total number of votes by race, county, and party. The total number of votes reported for the 2022 GE was 5,965,684ⁱⁿ.

This number, however, has to have a basis in the raw data reported in NYSVoter, the official federal record¹¹ of voter registration and participation. NY Citizens Audit received a copy of NYSVoter on 12/19/2022, four days after certification. When we tallied the voters who voted as recorded in NYSVoter, we were unable to reconcile the claim.

Certification of New York's 2022 general election appears to be a federal crime; a civil rights violation acting under color of law. Why?

Government by consent and the meaning of Certification

The King of America, the Law, is tethered to the Sovereign, the people, through the elective process. The loyalty of those we temporarily assign the privilege of writing and enforcing law is checked only by the honesty of our elections. Otherwise the King goes rogue. We cannot simultaneously have representative government and compromised elections.

Who is responsible for guaranteeing trustworthy elections? Under current federal law, each state has a chief election official who swears to and attests that an election is both accurate and legally compliant. This is the menaing of certification. Each of these individuals are bound to a sacred duty of maintaining accurate, valid, lawfully conducted elections, an incredible honor upon which our liberty pivots.

52 USC 20501 (National Voter Registration Act of 1993.)

SEC. 10. DESIGNATION OF CHIEF STATE ELECTION OFFICIAL. Each State shall designate a State officer or employee as the chief State election official to be responsible for coordination of State responsibilities under this Act.

SEC. 12. CRIMINAL PENALTIES. A person, including an election official, who in any election for Federal office-

- (2) knowingly and willfully deprives, defrauds, or attempts to deprive or defraud the residents of a State of a fair and impartially conducted election process, by—
 - (A) the procurement or submission of voter registration applications that are known by the person to be materially false, fictitious, or fraudulent under the laws of the State in which the election is held; or
 - (B) the procurement, casting, or tabulation of ballots that are known by the person to be materially false, fictitious, or fraudulent under the laws of the State in which the election is held, shall be fined in accordance with title 18, United States Code, or imprisoned not more than 5 years, or both.

If citizens reading clear election law and auditing the NYSVoter database found millions of potentially false, fictitious, and fraudulent registrations and votes, the chief election official knew or reasonably should have known about these violations, yet willfully chose to certify them as accurate and compliant.

A simple question

When officials certified New York's federal elections in 2020 and 2022, did certification meet the federal standard of accuracy and compliance? To answer this, the law defining that standard must be reviewed.

There are two kinds of elections in America:

- 1. ACCURATE
- 2. INVALID

To be accurate, elections must meet extremely stringent standards. The allowable system error rate in a federal election, in order for that election to be valid and therefore certifiable, is 1/10,000,000 ballot positions, or 1/125,000 ballots. According to the federal election assistance commission that set this legal standard, "This rate is set at a sufficiently stringent level such that the likelihood of voting system errors affecting the outcome of an election is exceptionally remote even in the closest of elections."¹² When it comes to federal elections, the law says there are no honest mistakes. Because the voter rolls are required by law to be accurate, every ballot tabulated is presumed to be from a voting eligible citizen. Thus the machine accuracy rate logically pertains to the voting system as a whole.

Was the 2022 election valid?

With a claim of 5,965,684 votes cast, the maximum allowable number of ballots in error for New York's 2022 general election, in order to be a legally valid, compliant, certifiable election, is 48. NY Citizens Audit found 745,246 apparent voting violations in excess of the legal standard.

Unexamined history repeats itself

Disturbingly, the following related information regarding New York's 2020 general election was substantially reported to the New York State board of elections on May 9, 2022, six months prior to the 2022 general election. No attempt was made to address the finding; it was dismissed outright and derided in the media. The certification of the 2022 general election proceeded under the same illegitimate conditions.

New York's 2020 and 2022 elections were not provably valid under the law. Certification appears to be a federal crime, a civil rights violation acting under color of law.

HAS NY CITIZENS AUDIT UNCOVERED ELECTION FRAUD?

Documents published by the NYS Comptroller as well as the Department of Defense Inspector General identify many of the issues presented in this report as probable cause for an investigation. The following guidance comes directly from the Inspector General¹³ and the NYS Comptroller¹⁴:

COMPREHENSIVE LIST OF FRAUD INDICATORS

- Management override of key controls.
- Lost or destroyed electronic or hard copy records.
- Photocopied documents instead of originals.
- "Unofficial" electronic files or records instead of "archived" or "official" files or records.
- Revisions to electronic or hard copy documents with no explanation or support.
- Use of means of alteration to data files.
- Computer-generated dates for modifications to electronic files that do not fit the appropriate time line for when they were created.
- Computer report totals that are not supported by source documentation.

- Hostile relationship between management and internal and/or external auditors. This would include domineering behavior towards the auditor, failure to provide information, and limiting access to employees of the organization.
- Failure to establish procedures to ensure compliance with laws and regulations and prevention of illegal acts.
- Indications that key personnel are not competent in the performance of their assigned responsibilities.
- Inadequate resources to assist personnel in performing their duties, including personal computers, access to information, and temporary personnel.
- Failure to effectively follow-up on recommendations resulting from external reviews.



- A manager that claims disinterest or having no knowledge about a sensitive or high profile issue in which you would expect management involvement.
- Services paid for violated a Federal, state, or local statute or regulation.
- Original documentation consistently unavailable for the auditor's review.
- Changes to the original documentation that do not appear to be authentic, such as different print or incorrect spacing.

RED FLAGS FOR FRAUD (parenthesis added)

- · Management ignores irregularities.
- · Staff lacks training.
- Reluctance to provide information to auditors.
- Management decisions are dominated by an individual or small group.
- Managers display significant disrespect for regulatory bodies.
- There is a weak internal control environment.

- Unexpected overdrafts or declines in cash balances (votes/voters).
- Photocopied or missing documents.
- Discrepancies between bank deposits and posting (deficits).
- · Excessive number of voids.
- Increasing number of complaints about products or service.
- Lack of physical security over assets/inventory.
- No supporting documentation for adjusting entries.



- Forgery.
- Creating fictitious employees (voters) and collecting the paychecks (votes).
- Breach of Duty.
- · Series of creative "explanations."

SUMMARY

THE THREE BASIC TENETS OF A VALID ELECTION:

- 1 Voter rolls must be accurate,
- 2 > Votes counted must be from qualified electors,
- 3 The number of votes counted must equal the number of voters who voted,

were all seemingly ignored in New York's 2022 general election, as they had been in 2020.

On May 14, 1888, the United States supreme court issued an opinion, regarding an election matter in Indiana. Cited in **"Federal Prosecution of Election Offenses**, Eighth Edition, *December 2017*," it is still considered good law:

Congress seeks by this statute to guard the election of members of Congress against any possible unfairness by compelling, under its pains and penalties, everyone concerned in holding the election to a strict and scrupulous observance of every duty devolved upon him while so engaged... . *The evil intent consists in disobedience to the law.* (In re Coy, 127 U.S. 731)

Is this why the chief election official of New York has described the honest, completely volunteer effort of over 2,000 New York citizens as "malicious," "false," and done by "bad actors"¹⁵? Charged with the public trust and paid by the citizens they are sworn to serve, our election officials statewide have largely ignored the simple solution to meet with NY Citizens Audit. Instead, using the false mantle of their self-appointed expertise, they have announced our claims are "baseless," and the provenance of our data is "fictional," despite having provided it to us. These are the public servants who, without providing the documentation to prove it, want us to take their word regarding our election outcomes.

The truth is, either by apathy, incompetence or malfeasance, election officials in New York have allowed the validity of our elections to become hopelessly compromised. This is demonstrated to have occurred in 2020 and 2022, at least. No one knows who won, by the will of the people, and the boards of elections are unable and unwilling to prove it to us. Our constitutional guarantee, of choosing the representatives we temporarily grant the privilege of writing and enforcing laws, via accurate, compliant elections, has been abridged, and probable cause for a full investigation by law enforcement has been demonstrated.

CONCLUSION

WE THE PEOPLE DEMAND A COMPLETE END-TO-END AUDIT, FROM CERTIFICATION THROUGH REGISTRATION, OF THE NEW YORK STATE 2022 GENERAL ELECTION,

for both paper and electronic records, including ballots, by a mutually agreed upon external, third-party bonded auditing firm, possessed of adequate insurance and indemnification for the handling and protection of the personal identifying information of millions of New York citizens, in order to determine the true error rate. This audit will provide a comprehensive report and analysis of all lapses and errors with explanation of cause where it can be determined.

We demand that this audit is completed well in advance of the upcoming 2024 primary and general elections, in order to successfully complete all needed repairs and ensure that the results of the 2024 elections are accurate, compliant, and trustworthy. Our domestic tranquility, as well as our responsibility to secure the blessing of liberty for the coming generations, requires it.

"The first grand right, is that of the people having a share in their own government by their representatives chosen by themselves, and, in consequence, of being ruled by laws, which they themselves approve, not by *edicts* of men over whom they have no control."

From "A Letter to the Inhabitants of Quebec," October 26, 1774, unanimously signed by the delegates to the First Continental Congress.

Agreement between the Town of Liberty and the Humane Society of Middletown, Inc. for the period beginning January 1, 2024 and ending December 31, 2024.

The Humane Society of Middletown, Inc. agrees to accept any dog brought to our shelter by your Animal Control Officer (ACO), or Dog Control Officer (DCO), from your municipality space permitting.

The dogs, in accordance with New York State Agricultural law, must be held for the legal holding period, after which they may be put up for adoption if not claimed by the owner. If said dogs are not claimed or adopted, they may be humanely euthanized.

If the Shelter must hold a dog beyond the legal holding time for your municipality because of a pending court case, bite case, etc., we will charge your municipality \$25.00 per diem, per dog. We can only hold up to three (3) animals for your municipality when the animals are seized by an ACO/DCO in the event of a cruelty case.

When leaving a dog that the DCO/ACO believes may be dangerous, the dog must be kept in the outside only part of the ACO/DCO pen and follow the agreed upon protocol. Written information must be given to the shelter or the shelter manager that clearly communicates that the animal may be dangerous.

Since we do not have a veterinarian on premises, we are unable to accept any animal with suspected mange, rabies, distemper, parvovirus or an injury that requires immediate medical attention. These animals will have to be taken to a veterinarian by your ACO/DCO for treatment or euthanasia. Any resulting bills for these animals will be paid directly to the veterinarian by your Town/City.

If the Humane Society assists your municipality due to the unavailability of your animal control officer or police department, your municipality will be billed an additional fee of \$100.00.

The municipality will pay a fee of \$300.00 per dog delivered to the Society. The municipality will pay a fee of \$75.00 per cat delivered to the Society. A flat rate of \$100.00 will be charged for each dog delivered DOA. A flat rate of \$50.00 will be charged for each cat delivered DOA.

The Humane Society will send out vouchers once a month. A record of the disposition of the dogs from the prior month will be sent out by the end of the month.
