#### What were the strengths of this discussion section?

#### Comments

The sections were a great opportunity to get questions answered, to engage with the material collaboratively, and to connect what we were learning about to relevant current events. I always enjoyed them.

This was one of the most interactive and engaging discussion sections that I've had so far. I felt like I always had the opportunity to participate; not only that, others in the class were encouraged to participate, too, which ensured that multiple voices were heard in every section. The section activities provided memorable ways to review the lecture material and prepare for the midterm/final.

Haley was incredibly organized and made participation and classroom participation super comfortable – students could participate in a variety of ways depending on their comfort level. I also think it helped to reinforce the lecture material really well and I enjoyed learning more about the applications of our lectures to real world careers etc.

The GSI worked to simulate a law school "cold–call" atmosphere while also being accommodating for those who did not wish to be called upon in class. I think this format of discussion was great and kept us all on our toes.

The GSI was well prepared with discussion material. She also connected the course material to real life examples/situations.

The strengths of the discussion section were that it allowed clarifying any questions, but also to have a deeper discussion about human rights and, most importantly relating it to current events.

#### What skills did you develop in this section, and how did you develop them?

#### Comments

Through the activities and conversations in the discussion section, I developed the ability to speak aloud about and discuss the class material rather than simply learning it.

Being prepared (due to the instructor's cold calling), thinking critically (due to the section activities and instructor's questions), evaluating and responding to others' opinions (through activities and discussions)

I think this section's 'cold—calling' initially made me really scared but I think it helped me develop a confidence in the classroom in my ideas as well as a clarity in how I convey them.

I learned how to efficiently revise and review my notes before discussions in case I was cold–called and this allowed me to focus on main concepts instead of getting bogged down in details.

Public speaking and critical thinking (i.e., applying course material to real human rights situations currently occurring)

I think that the most important skill that I developed in this class was being able to be called on and present an idea. It made me get out of my comfort zone.

Ability to ask more questions, participate more

#### How did the GSI include, or fail to include, all of the students in this course?

#### Comments

The GSI included all students by calling on everyone and ensuring that each person had a chance to ask questions or provide their opinion.

The GSI included all students in the course by asking questions to all students, regardless of whether or not they actively volunteered to answer the question. Even if they were unsure of the answer, their response contributed something to the discussion —if they were confused, for example, their questions could help clarify the material. In this way, everyone was included in the discussion and everyone's concerns/doubts could be addressed.

Haley made sure there were different ways for students to participate if they weren't comfortable being called on through group discussions, office hours, and discussion posts.

The GSI maintained attendance during each section and used this to ensure that each person was inputting ideas/ bringing something to the table.

Included all students via a checklist to make sure all students wither spoke in class or contributed to the discussion via bcourses.

I think that one thing I really appreciated of this instructor was that she wanted everyone to participate and she cold-called on you, but she understood that if you get nervous speaking in front of the entire class then she allowed for you to participate through discussion board.
